Fire Marshal

EMS Captain, Bob Fager, updated the board on the new ambulance build and reported everything looked to be on schedule. He also shared some photos with the board on the building progress.

President Kellar stated that the Emergency Declaration is still in effect until the board decides to lift it. He stated that supply chains are opening for PPE and the Governor's Order expires on the 26th. Most EOC's have gone virtual and talking about switching to recovery mode.

May 2020 Election Updates

President Kellar updated the board regarding last meeting's discussions which ensued of considerations for changes to normal election processes due to COVID-19, as he would inquire about the possibility of mail-in ballots for our May election. He stated the change in election cost for mail-in ballots is \$8,600. He stated that the candidates were in today's paper and that Bob Fager was organizing a Zoom Meet the Candidates on April 29th.

Water District Overview

President Kellar reviewed with the board the email from the IH Water District. Two tanks are still off-line in Zone 1 and Zone 3. The well production currently above average (due to the time of the year). The numbers in Zone 1 this week indicate a leak and they are scheduling repair at the Turkey Creek hydrant and will see if that affects the numbers after completion. Hydrant maintenance and flushing will be scheduled for May/June and the water district will keep us posted on the dates. The IH Water District made a switch from an ORC employee to a Contract ORC which took effect 4/10/20.

NEW BUSINESS

Wildfire Mitigation Messaging

Once it starts to dry and warm up, we can produce a Smoke Signals to distribute to the public. Mike Fassula can assist with the information to include regarding Wildfire Mitigation.

Fourth of July Parade

As of now, the Pancake Breakfast does not sound possible, however, the board decided to table this until the May meeting to make a final decision. Fun Run is still on with regards to social distancing guidelines and we may be able to base some of the other events on information available at the time regarding social distancing.

2020 Strategic Planning Session

The dates for strategic planning will be determined after the election at the May Board Meeting and will probably be late July or early August. The plan is to put long-term projects in place and a district plan for upcoming years, pension board included.
