The department ordered a new topper for 351. Paramedic school is still going strong for the chief, and he will be going to cadaver lab tomorrow! Chief Mark Forgy and Fire Captain Mike Fassula had a video conference update and work meeting with Ember Alliance last week and have another one planned next week. We've seen some of the early mapping for forecasts and now we are gathering more information about evacuation congestion points along with points of contact for public outreach. Jackie Kniss and the Boots crew are moving along on the planning for the awards banquet.
